We are planning on applying for grants. A discussion was had. The tax levy was meant to accrue money for planning of plans. Two major expenses around planning. The Comprehensive Lake Management planning every 10 years. Every five years a Aquatic

Plant Management Plan. Comprehensive plan probably in 2028 or 2029. The District will look into state grants.

#### **OLD BUSINESS:**

Lake District Insurance: Bob has received one bid on insurance. He still is in the process of trying to obtain other bids for insurance.

Rate: Mill or Parcel Update: A healthy discussion was led by Steve Heimerman on mill rate vs parcel rate. No decision was made on either rate. The rate will be explained at the Annual meeting on 2 September 2023 and a vote by the people will decide the type of rate. Steve will make the presentation at the September meeting.

Membership notification update: Mark Wildenberg is getting the specifics on having our mailouts handled professionally. If professionally done it must be to the printer by 14 August 2023.

Facebook Page: Discussion was had in the beginning of the meeting under Committee Updates.

Decision on place to host the annual meeting: Bob reported the most likely place will be the Brazeau Town Hall. People made other suggestions. The Town Hall still seems to be the top choice.
